## LEMONT FIRE PROTECTION DISTRICT MINUTES OF JUNE 20, 2024 REGULAR MEETING OF THE BOARD OF TRUSTEES

CALL TO ORDER: Trustee Joseph Falese called the regular meeting of the Board of Trustees of the Lemont Fire Protection District to order on June 20, 2024, at 6:00 PM. The meeting was conducted at 15900 New Avenue, Lemont, IL.

Trustee Falese led the Pledge of Allegiance.

COMMUNITY ENGAGEMENT REPORT: Minutes Matter Facilitating Team Members: Communication Chair Lisa Kross, Canvassing Chair Tracey Papesh, Community Chair Ryan Raetzman presented a power point to the Board, reporting findings and feedback from the Minutes Matter community engagement campaign. FINANCIAL REPORT: Chief Tasso invited John Falduto of Asset Management, LLC to provide a monthly report of the District's investment portfolio.

COMMUNICATIONS FROM THE BOARD: Trustee Negrete thanked DC Peksa, DC Truffa, Trustee Tholotowsky, and Trustee Falese for their efforts on the Community Engagement initiative. Trustee Tholotowsky thanked the union for their efforts on the canvassing weekends. Trustee Tholotowsky extended sympathies to the Smollen family on the passing of Mike's mother. Trustee Tholotowsky wanted to remind everyone how dangerous fireworks are and to leave them to the professionals. Trustee Tholotowsky shared Sara Tholotowsky will be graduating from Romeoville Fire Academy. Trustee Smollen thanked the Board for supporting his family in their time of loss.

ATTORNEY REPORT: Attorney Motylinski states the legislative chair is out of session and 2 bills previously mentioned are awaiting signatures. He will keep the Board informed and update as needed.

CHIEF'S REPORT: Deputy Chief Peksa let the Board know the new Hazmat Squad is slated for radios and graphics and should be back in the next week. He reports 3 Firefighters are on Workers Comp, down from 4. Two shifts are on variances with reduced staffing from 13 to 12. He informed the Board we had 361 calls in May, which is a decrease from last May but still trending a 5.8% increase for this year.

Deputy Chief Truffa informed the Board the new ambulance is stocked and awaiting IDPH inspection and expects it will be in service in the coming weeks. He let the Board know EMS Director Tyler Yost will be on extended leave as he takes care of a scheduled procedure. DC Truffa and the EMS committee will be picking up the workload in Yost's absence. DC Truffa explained to the Board that a new Public Education Coordinator is expected to start next week.

Chief Tasso recognized those who had work anniversaries in June: Union President Dave Gubbins with 15 years and Eric Windmoeller and Matt Winfield, both celebrating 4 years with the District. Fire Chief Tasso informed the Board 28 applications were taken from applytoserve.com and 18 applicants showed up to take the test on 6/20/2024. Oral interviews are scheduled for July 10<sup>th</sup>. Chief Tasso expressed his appreciation to the Minutes Matter facilitating team for all their hard work and research on the Minutes Matter Initiative.
